Terms & conditions

1. This offer is only available to new Consultants with a 60 Day Program start date between 1st September and 30th September 2020. TM6 Ambassadors are eligible if they have held this status for six or more months.
2. You can only earn one TM6 under this Agreement and the criteria for earning a TM6 is outlined in the table above.
3. By signing this Agreement, you agree to purchase a Business Kit for \$175, pay a deposit of \$850 on a new TM6 plus \$20 shipping and provide your credit card details as surety for payment. Upon signing the Agreement, we will deduct \$1045 from your nominated credit card or Zip account.
4. This deposit is non-refundable unless you achieve 4 closed sales within your 60 Day Program.
5. We will deliver a TM6 and Business Kit to you and you will be provided with a copy of our Terms and Conditions of Sale.
6. Subject to Clause 10 below, you authorise us to deduct a payment from your nominated credit card account or Zip account, in an amount specified in the table above and not before the end date of your 60 Day Program. Where Zip Pay is your preferred payment option you must provide your credit card details to support the buy-in and authorise us to deduct payment from your nominated credit card account.
7. You may cancel this Agreement within 10 clear business days of the date of signing. Upon cancellation you must return the TM6 and Business Kit to us at your expense. If you have damaged the TM6 or have caused the TM6 to no longer be in an as-new condition, we reserve the right to dispute the cancellation of this Agreement.
8. You agree that you will not receive any Commissions on closed Thermomix sales that contribute to you earning a TM6 under this Agreement. However, all closed sales made under this Agreement will count towards all other incentives and reward programs, unless expressly excluded.
9. Upon achieving 4 closed sales and earning a TM6 under this Agreement, the commission on your next closed sale will start at level 1 of the Consultant commission table in the Contractor Commission and Incentive Plan.
10. You must commence the 60 Day Program within 30 days of signing the Contractor Agreement Form (CAF). If this does not occur, The Mix Australia may charge your nominated credit card the full balance owed.
